AND WITNESSETH :**

- 1) That in pursuance of the premises above the Author of the Trust as settlor doth hereby convey unto and settle upon the Trustees have handed over the said amounting to Rs. 4,00,000/- (Rupees four lacks only) the upon trust and the Trustees do each of them doth hereby admit and acknowledge the transfer to them with powers and subject to the uses mentioned hereinafter.
- 2) That the SRISTI GUIDE LINE EDUCATION & WELFARE TRUST name of the Trust shall authorise public charitable Trust with its register office at No. 1 govt Colony, P.O. Malda, P.S. - English Bazar, Dsit. - Malda, State of West Bengal, Pin - 732101.
- 3) That name of the Trust shall be Sristi Guide Line Education & Welfare Trust and the office of the trust shall be situated at No. 1 Govt. colony, P.O. -Malda, P.S. - English Bazar, Dist. - Malda, which may be shifted from time to time to such other Place as the trustees may deem fit and proper at their discretion.
- 4) If any one or more of the objects in clause (3) of there present are held not to be objects of a public charitable nature, the TRUSTEES shall not carry out such object or objects as if the same are not incorporated in these present but the validity of the trust created by these presents as a trust for public charitable purposes shall not be affected in any manner.
- 5) That the Trustee shall stand possessed of cash hereby conveyed and settled upon and shall use and apply the interest the profit and other income derived thereby for the purpose and object of the Trust as aforesaid.
- 6) That the Founder of the Trust being absolute owner of the properties dedicated hereto the Trust, hereby conveys all property fully described above in the schedule annexed hereto as well as movable assets consisting of cash amount of Rs. 4,00,000/- (Rupees four lacks only) Government Promissory Notes to the Trustees to held the same upon Trust and with under the Subject to the Powers and Provisions herein contained.

7) i) That the Trustees shall subject to submit a building plan suitable for the purpose and shall on sanction of the building plan from the prescribed authority.

ii) The Trustees shall engage and employ such teaching, clerical and mental staff for imparting education, maintaing office cleaning the premises and other acts essential for the purpose. Such staff will be paid such remuneration as the elected body of the trustees member.

iii) The Trustees will defray the expenses incurred for the purpose of the Trust out of the income of the Trust Funds and Properties If, however, the income occuring in the normal course from the funds and properties dedicated is found insufficient for meeting the ends of the Trust.

iv) The Trustees shall have no power to alienate the Trust Properties or encumber them even for essential needs, without premission of the General Body of the Trust and who regularly contribute the annual subscription for the membership of such Assembly.

v) The Trustees may invest the surplus funds of the Trust in their hands accured from property of Trust or otherwise by donations etc. in Governments Securities or fixed deposited in the state Bank of India or other Schedule and Nationalised Banks as found convenient to them.

8) That the cash hereby conveyed to the Trustees shall from the corpus at the Trust property but the Trustees shall have power from time to time to increase or decrease the corpus of the Trust excepting in exceptional circumstances of need and only on the unanimous decision in that regard of the Board of Trustees at the material time.

9) The Founder of the Trust shall be one of the Trustees and after his life the member of his family or descendants shall be a Co-Trustee in the absence of a member in his family or descendants only educated member shall be a co-trustee.

10) That the TRUST Shall be governed by a Board of Trustees. The Board of Trustees for the time being shall constitute of Trustees here inafter mentioned which is hereby authorized and empowered to nominate any other person as Trustee as long as the total member of the Trustees at any time does not exceed 5 (five). In the event of death, incapacity, insolvency resignation or refusal on the part of any Trustee to act as such the remaining Trustees shall be entitled to nominate any other person as they think fit and proper to act as Trustee in place of the Trustees so dying, is capacitated declared insolvent, resigning or refusing to act as such the nomination of any person as a Trustee shall be either unanimous or by a majority decision and in the event of the trustees being equally divided on the nomination of any person, the decision in the matter of the managing Trustee shall be final and conclusive.

11) That the administration of the Trust hereby constituted and the entire control, supervision, regulation, management of the Trust properly and even the application of the entire or apart of the income and the profits there of as also of all the donations and contributions and subcription, if any, received by it shall vest in the uncontrolled discretion, of the Board of Trustees subject however always to the provisions contained as hereinbefore.

12) That the Board of Trustee may frame rules ad regulations for the administration of the Trust and for carrying out the purpose and object thereof and the same may be varied altered, Substituated or added to from time to time by a unanimous decision of the Board of Trustees with a view to introduce more effective administration and carrying out the purpose and the object of the Trust such rules may specifically provided the basis or crltertion of the selection of the students for the

15) That the Board of Trustee may elect or nominate any of them as the managing Trustee for any period of time, but the first Managing Trustee shall be Author of the Trust and he shall hold that office and position upto the time of his death, incapacity, insolvency, resignation or refusal, to act as such.

16) That the first meeting of the board of Trustees shall be held within three (3) months of the date of the execution of this deed and shall be summoned by the Author of the Trust by giving at least 7 (seven) days notice in writing to all the

Trustees to be held at such place and time as may be specified in the notice and in that meeting all relevant matters relating to the Trust shall be considered in all possible details and particularly the ways and the manner to give effect to the provisions of the Deed of Trust and to attain the object and purpose of this Trust.

17) That the Trustees are hereby authorized and empowered to appoint a secretary to carry out the duties assigned to him in relations to the execution of this Trust and the pay to him out of the Trust Fund such remuneration as the Trustees for the time being may think fit, provided that if any one of the Trustees be appointed as the secretary, he/she shall not be entitled to receive nor shall be paid any remuneration. The Trustees may also appoint such staff as they deem expedient and necessary for the purpose of the Trust at such salary as they may decide upon in each case.

18) That the subject to the provisions here inbefore contained the Trustee shall not keep in hand either themselves or together with the secretary and / or any other employee of the Trust or any other person at any time more than Rs one lacks and about in cash belonging to the Trust Fund and all cash belonging to the Trust shall be deposited with the selected Bank by the Trustee or any other scheduled Bank which the Trustees may decide upon. The Banking Account relating to the Trust Fund shall be operated under the signatures of at least two trustees out of which the managing Trustee shall be one, but if at any time, there is no managing Trustee of the fund as elected or nominated as such then the banking account relating to the Trust shall be operated only under the signatures of all the Trustees of the fund at the material time.

19) That the Trustees may in their untrilled discretion deposited for safe custody any documents or securities relating to or forming part of the Trust property with the Bank or Banks as aforesaid on payment of such charges there of. If any, as may be agreed upon and found expedient in the interest of the Trust.

20) That the meeting of the Board of TRUSTEES may be held at such time at such place and on such dates as may be agreed upon by the Trustees. Such meetings may be summoned by any one or more of the Trustees by giving at least 7 (seven) days notice in writing to all the Trustees, specifying the time, place and the date of the meeting and also indicating the purpose of such meeting. 21) That the true and proper accounts of all the receipts and disbursements relating to the Trust hereby constituted shall be kept by the Trustees, the secretary thereof and / or the employees of the Trust, who have been assigned the duty in that regard. on or after the 31st march day of each year an income and expenditure account for the whole year upto that date and a balance sheet of the assets and liabilities as on that date relating to the affairs of the Trust shall be prepared by the 30 the day of June of that year. These accounts and the balance sheet shall be duly audited and examined by a chartered Accountant, which may be engaged by the Board of Trustees for the purpose of such audit on such remuneration as they may deem necessary and desirable. As soon as may be after such audit, a meeting of the Board of Trustees shall be held at which the accounts of the Trust hereby constituted and the report of the auditor concerning the same shall be examined and adopted.

22) To appoint or make provision for the appointment of a sub-committee of trustees and / or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

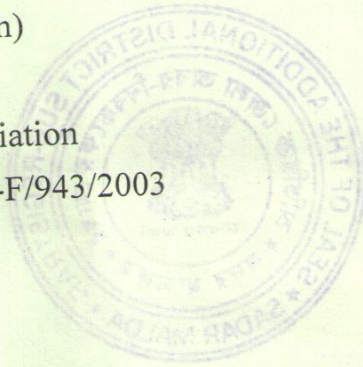

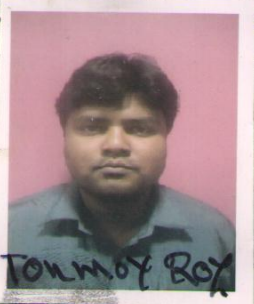

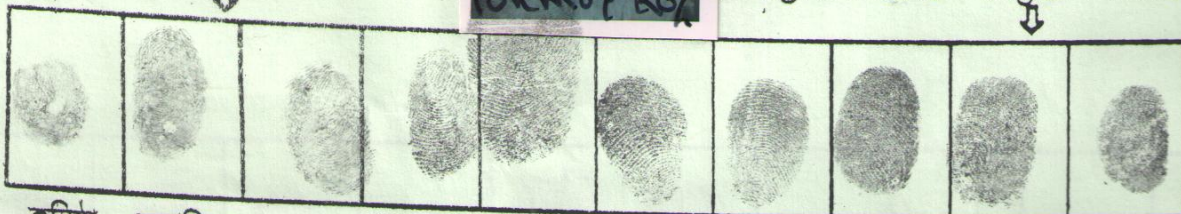
